Subject: HIV Community Funding Request for a National HIV Pre-Exposure Prophylaxis (PrEP) Program

Dear Chairs Murray and DeLauro and Ranking Members Blunt and Cole:

As you move forward with final negotiations for the FY2023 appropriations process, we urge you to invest \$30 million in expanding HIV pre-exposure prophylaxis (PrEP) nationwide within the Centers for Disease Control and Prevention (CDC) Division of HIV Prevention in the FY 2023 Labor, Health and Human Services, Education, and Related Agencies (LHHS) appropriations bill. Such funding is a necessary first step toward achieving a national PrEP program. It is an essential investment to reach the ambitious targets put forth in the bipartisan *Ending the HIV Epidemic* initiative.

In a recent 2020 report the CDC estimates that nationally, 66% of white people who could benefit from receiving PrEP use it, compared to only 9% of Black people and 16% of Hispanic/Latino people, leading to greater disparities in HIV for people of color. Additionally, only 9.7% of women who could benefit from PrEP currently have a prescription. Many of these same populations are disproportionately uninsured.

Congress and the Federal government must quickly act to ensure that anyone who in uninsured and underinsured and would benefit from PrEP can access the medication and other PrEP services without any costs. For every year that we delay scaling up access to effective, evidence-based HIV prevention through PrEP, over 35,000 unnecessary new infections will occur in the U.S., concentrated primarily within vulnerable communities and communities of color. This new program would expand PrEP access by providing grants to a wider range of provider networks.

As part of this request, we urge the Committee to adopt the following report language to ensure that this funding is effectively distributed:

Domestic HIV/AIDS Prevention and Research. Access to PrEP.— In support of the vision of ending the HIV epidemic, the Committee includes an increase of \$30 million to the Centers for Disease Control and Prevention (CDC) Division of HIV Prevention to increase equitable access to pre-exposure prophylaxis (PrEP) nationwide. Additionally, the Division should use existing funding to increase access to PrEP. The committee is concerned that only 25% of people who could benefit from PrEP, an effective HIV prevention medication, received a prescription in 2020, with only 9.7% of women, 9% of Black and 16% of Hispanic/Latino people in need of PrEP having access compared to 66% of their White counterparts. This funding should support planning and launching a national program to increase access to PrEP medications; laboratory services; essential support and wrap around services, such as case management, counseling, linkage, and adherence services; robust PrEP outreach and education activities; and PrEP provider capacity expansion. The Committee further directs CDC to examine and remove limitations on grantees' abilities to use HIV prevention grants and cooperative agreements on PrEP medications, laboratory services, and clinic visits for people who are uninsured or underinsured. CDC shall submit a report to the Committee within 180 days of enactment of final FY23 appropriations on the status of a national PrEP initiative.
